4. That the school shall comply with the provisions of Section 10 (1) read with Rule 125 of DSEAR, 1973.
5. That the school shall observe the relevant provisions of RTS Act. 2009. DSAR 1973 and directions/instructions issued by the Department from time to time
6. That the school shall comply with the orders/guidelines of Doe and judicial pronouncement w.r.t. utilization/maintenance of school funds.
7. The extension of provisional recognition may be granted subject to condition that the school authority shall submit renewed FDR in the joint name of DDE North and Manager of the school.

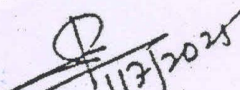
10. That the school shall appointed 2nd special educators within 01 months from the issuance of letter of approval to the District Authority.

12. The extension of provisional recognition may be granted subject to condition that the school authority shall submit fresh Fire Safety Certificate issued by Delhi Fire Service to DDE (North) within 01 months.

13. That the DDE District shall ensure that the aforesaid terms & conditions are being complied with by the school management in letter and spirit.

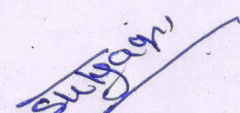

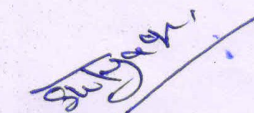

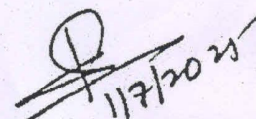
